EPN® System Growth

For those who want to do scheduled batch payments, the EPN® system is continuing its trend of annual growth. The EPN® system processed 20.7 billion transactions worth \$56.4 trillion in 2024, which represents 6.2% growth for 2024. This February, the system achieved a new single-day volume record of 152.4 million transactions.

In February, The Clearing House raised the value limit on the RTP® network from \$1 million to \$10 million per transaction. New RTP® Network Records

In a world of instant interactions, customers expect their payments to keep pace. If instant payments are offered, customers are often choosing them, and that demand is driving instant payments adoption. More than \$246 billion moved over the RTP® network in 2024, up a whopping 94% from 2023, while transaction volume jumped 38% to 343 million. In Q1 of this year, the RTP® network set new records for volume and value.

We passed the one billion transaction mark in early February and have recently achieved a record of \$4.9 billion cleared and settled within a single day.
